### Accomplishments and Initiatives

Dear Friends and Neighbors,

As 2023 draws to a close and Freshwater Grange prepares for a new year, it is with pride that we look back upon all that we have accomplished this year . Truly, the last 2 years have seen so much change and growth for our organization and our building. We are grateful to our members, our volunteers, and our supporters. Without you we would not have come so far in achieving our goals for Freshwater Grange. Here is a recap of our accomplishments.

- In 2022, the Grange interior was repainted throughout the hall, and improvements were made to the kitchen by installing new cabinets, an additional sink, and updated lighting. We upgraded the stage area and remodeled the bathrooms and the foyer. These improvements made the hall a more efficient and appealing venue for members and renters.

- Since May 2022, the Grange has been serving our Pancake Breakfasts on the first Sunday of the month in the main hall instead of in the downstairs area. This arrangement increases the amount of work for our volunteers but makes it possible to serve a greater number of community members and provides expanded access to diners of all mobility levels.

-We have created Gallery 499. At each breakfast the Grange displays artwork of various mediums by a rotating collection of artists. Mediums include quilts, watercolors, photography, etc. We invite you to reach out if you would like to be a featured artist.

- Freshwater Grange has become a viable rental venue. Garfield School and its Booster club enjoy use of the hall at a generous discount and there are a growing number of weddings, birthday parties, birth and engagement gatherings, and memorial services held at the hall. A benefit of Grange membership is a discount on hall rental fees.

- A community member has made a generous donation to upgrade the heating in the hall. The Grange purchased a heat pump system and now the main hall is warm for this winter and will have air conditioning for the summer.

- The Grange hosted a variety of monthly events including lectures, St Paddy's Bingo, Mother's Day Craft Fair, Halloween festivities, Friendsgiving, and more.

-Our website, launched www.freshwatergrange.com, was launched to provide the public a site to access information on our events, classes, rentals, and more. We have also been hard at work to keep our Facebook and Instagram accounts up to date.

- Members and the broader community continued utilize our classes at no or low cost. The senior exercise program S.A.I.L. (Stay Active and Independent for Life) is offered Tuesday and Thursday from 9:30 to 10:30 free of charge.

- We continued to support other nonprofits through discounted hall rentals, donations, and supply drives.

-Keeping community safety at the heart of our developement goals, we developed a plan for renovations and upgrades that would see the Grange become a hub for the community in an Emergency situation. Energy independance is a step towards that goal. Our fundraising efforts have allowed us to purchase solar panels and equipment. We will install the panels in 2024 when we have reached our fundraising goal. Please consider donating to our Rays on The Roof fundraiser!

-The Grange has opened the <u>"Freshwater Grange Fund"</u> with the Humboldt Area Foundation. Donations made to the fund are <u>tax</u> <u>deductable</u> and will be used to pay for improvements and upgrades to the hall.
